This exercise helps everyone understand how each other works.

There was discussion on what it means to be MCC today, current global, cultural, and spiritual settings and factors (including social justice issues like marriage equality, gender diversity and identity, etc.). We also explored the concepts and differences in conforming and transforming, in relation to our vision and mission "transforming ourselves as we transform the world."

Committees:

Discussion was held to define what each of the Board working committees are responsible for and what specific roles will be.

Finance:

We referred to the Finance Committee the issue of signors outside of USA. We talked about transitional matters from old board members to new, and considered ways to roll

all of this in with our upcoming 50 Anniversary celebrations. We agreed a need to redefine the make-up of the Finance Committee and recommended considering options for international banking.

Development:

The primary role of the Governing Board is to identify, grow and sustain financial and other resources for the organization. In general discussion of this role, we agreed that relationship building is key, expanding our understanding and practices in international philanthropy, funding needs (not wants), and looking more broadly and creatively at Fund Development in our global and local contexts.
